

Fall 2025 Children's Product Safety Commission Recalls

DTR STITCH 4-pack Scented Highlighters

Primark Recalls DTR Stitch 4-pack Scented Highlighters Due to Risk of Phthalate Exposure; Violates Federal Phthalates Ban; Sold by Primark

Hazard:

The scented highlighters, which resemble cups with straws, contain phthalates; a violation of the federal phthalates ban. Phthalates are toxic if ingested by young children and can cause adverse health effects.

URMYWO Baby Loungers

URMYWO Baby Loungers Recalled Due to Risk of Serious Injury or Death from Suffocation and Fall Hazard; Violates Mandatory Standard for Infant Sleep Products; Sold on Amazon by Pomona

Hazard:

The baby loungers violate the mandatory standard for [Infant Sleep Products](#) because the sides are shorter than the minimum side height limit to secure the infant; the sleeping pad's thickness exceeds the maximum limit, posing a suffocation hazard; and an infant could fall out of an enclosed opening at the foot of the lounger or become entrapped. The portable loungers do not have a stand, posing a fall hazard. These violations create an unsafe sleeping environment for infants, posing a risk of serious injury or death.

Children's Spiral Tower Toys

Children's Toys Recalled Due to Risk of Serious Injury or Death from Choking; Violates the Small Ball Ban; Sold on Shein by STWUQIKONG

Hazard:

The recalled toy contains small balls and is intended for children under three years of age, which violates the small ball ban, posing a deadly choking hazard.

TEMI Go Basketball Toys

TEMI Go Basketball Toys Recalled Due to Risk of Serious Injury or Death from Choking; Violates Small Ball Ban; Sold on Amazon by Temitoys

Hazard:

The recalled toy contains small balls and is intended for children under three years of age, which violates the small ball ban, posing a deadly choking hazard.

Tegu Magnetic Floating Stackers

Tegu Recalls Magnetic Floating Stackers Toys Due to Magnet Ingestion Hazard; Risk of Serious Injury or Death; Violates Mandatory Standard for Toy Magnets

Hazard:

The recalled magnetic floating stackers toys violate the mandatory standard for toy magnets because they contain magnets that can loosen and detach from the toy, posing an ingestion hazard to children. When high-powered magnets are swallowed, the ingested magnets can attract each other, or other metal objects, and become lodged in the digestive system. This can result in perforations, twisting, and/or blockage of the intestines, blood poisoning and death.

LIVACTI Retractable Safety Gates

LIVACTI Retractable Safety Gates Recalled Due to Risk of Serious Injury or Death from Entrapment; Violates Mandatory Standard for Gates and Enclosures; Sold on Amazon by Qeyan and Yanyanny

Hazard:

The recalled gates violate the mandatory standard for expansion gates and expandable enclosures because a child's torso can fit through the opening between the gate and the floor, posing a risk of serious injury or death due to entrapment.

Minecraft Light-Up Slap Ruler Bracelets

Innovative Designs Recalls Minecraft Light-Up Slap Ruler Bracelets Due to Risk of Serious Injury or Death from Button Cell Battery Ingestion Hazard; Violates Mandatory Standard for Toys

Hazard:

The battery compartment of the recalled light-up ruler bracelets can be opened easily by children, allowing access to the button cell batteries, violating the battery-operated toys requirements under the mandatory standard for toys. If a child swallows a button cell or coin battery, it can cause serious injuries, internal chemical burns or death.

Dearlomum Retractable Safety Gates

Dearlomum Retractable Safety Gates Recalled Due to Risk of Serious Injury or Death to Children from Entrapment Hazard; Violates Federal Standard for Gates and Enclosures; Sold on Amazon by Signbaby

Hazard:

The recalled gates violate the federal standard for expansion gates and expandable enclosures because a child's torso can fit through the opening between the gate and the floor, posing a risk of serious injury or death due to entrapment hazard.

Creekliybear Play Yard Mattresses

Creekliybear Play Yard Mattresses Recalled Due to Risk of Serious Injury or Death from Entrapment Hazard; Violates Mandatory Standard for Crib Mattresses; Sold on Amazon by Kbabyea

Hazard:

The aftermarket play yard mattresses violate the mandatory standard for [crib mattresses](#), as the mattresses exceed thickness requirements and may not adequately fit certain play yards, posing a deadly entrapment hazard. Babies can suffocate in gaps between an undersized mattress, or extra padding, and side walls of a product, especially when the infant's face becomes trapped against the side and the mattress, preventing the infant from breathing.

Tatamia 3-in-1 High Chair**Peg Perego Recalls Tatamia 3-in-1 Recliners, Swings and High Chairs Due to Risk of Suffocation; Violations of Multiple Federal Standards (Recall Alert)****Hazard:**

The 3-in-1 products pose a suffocation risk because they were marketed for infant sleep, and they have an incline angle greater than 10 degrees, in violation of the [Infant Sleep Products Rule](#) and [Safe Sleep for Babies Act](#). In addition, the products fail to meet mandatory warning requirements under the high chair standard.

Boyro Baby Walkers**Boyro Baby Walkers Recalled Due to Risk of Serious Injury or Death to Children from Fall Hazard; Violations of the Federal Standard for Infant Walkers and Lead Content Ban; Sold Exclusively on Amazon.com****Hazard:**

The recalled baby walkers violate the federal safety standard for infant walkers because they can fit through a standard doorway and fail to stop at the edge of a step as required, posing a risk of serious injury or death due to a fall hazard. In addition, the baby walkers' brake pads contain levels of lead that exceed the federal lead content ban that are prohibited in children's products by the Federal Hazardous Substances Act. Lead is toxic if ingested by young children and can cause adverse health effects.

Bell Sports Bicycle Helmets**Bell Sports Recalls Bicycle Helmets Due to Risk of Head Injury; Violation of Federal Standard for Bicycle Helmets****Hazard:**

The recalled helmets do not comply with the impact requirements of the Consumer Product Safety Commission's (CPSC) mandatory federal safety standard for bicycle helmets. The helmets can fail to protect the user in the event of a crash, posing a risk of head injury.

TADAKAZU Baby Loungers

TADAKAZU Baby Loungers Recalled Due to Risk of Serious Injury or Death from Suffocation, Fall and Entrapment Hazards; Violations of Federal Standard for Infant Sleep Products; Sold on Amazon

Hazard:

The recalled portable baby loungers violate the federal safety standards for [Infant Sleep Products](#) because the sides are shorter than the minimum side height limit to secure the infant; the sleeping pad's thickness exceeds the maximum limit, posing a suffocation hazard; and an infant could fall out of an enclosed opening at the foot of the lounger or become entrapped. The portable loungers do not have a stand, posing a fall hazard. These violations create an unsafe sleeping environment for infants, posing a risk of serious injury or death.

Giraffe High Chairs

Bugaboo North America Recalls Giraffe High Chairs Due to Risk of Serious Injury or Death from Fall Hazard

Hazard:

The highchairs pose a fall hazard and risk of serious injury or death to babies because the legs of the chair can detach from the frame if the screws connecting the legs are not properly tightened during assembly.
